

Course Description

This course will introduce students to academic research and writing with an emphasis on professional writing in criminal justice research and in the criminal justice field. It is imperative that students entering the workforce (in all areas of criminal justice) have a solid foundation in manuscript structure and the professional writing style of the field. Topics will include the "why and how" of criminal justice writing and guidance on how to write accurately and concisely at the same time. This course emphasizes grammatical structure, use of capitalization and punctuation, sentence structure, topic development, and critical analysis.

Course Objectives

This course is intended to introduce and familiarize students with:

- ✓ APA manual writing standards and style requirements
- ☑ Structuring of both informative and persuasive type papers
- ☑ Writing, formatting, and properly citing academic papers
- ☑ Defining paper topics/research problems and crafting strong hypotheses
- ☑ Conducting academic research and finding credible sources
- ☑ Writing annotated bibliographies, literature reviews, reports, and manuscripts

Course Requirements

Syllabus

Students must read this syllabus thoroughly and in full, and are responsible for every policy listed herein. Students are required to complete and sign the "JS100W Course Contract" during the first week of the semester, which indicates that they fully acknowledge all of the terms of the class and agree to be held to all course policies as listed in the syllabus.

Attendance

Class is held in-person twice a week on Tuesday/Thursday from 12pm - 1:15pm in SH239. Students are expected to arrive on time and be prepared for class. Attendance is required for both learning and performance. Class will consist of a combination of lecture and writing exercises. In the event of an unexcused absence, students are responsible for all material covered in class, and for any announcements or assignments.

Canvas

In addition to in-class meetings, Canvas will be a primary source of course information, and the method of distribution for any announcements, assignments, assigned readings, or class material. It is the student's responsibility to check Canvas regularly and to receive the Canvas email notifications.

Assignments

Assignments will be posted on Canvas on the date they are assigned, and are to be submitted through Canvas unless otherwise specified. Assignments are due by the date/time listed on the course schedule and/or the Canvas assignment instructions.

All stages of the writing process are required. Failure to submit either the preparatory stages, the first draft, or the final version of paper assignments will result in an "F" for the course. All papers are required to be in Microsoft Word Document format (.doc or .docx), and no other format will be accepted. Submissions will be automatically routed through turnitin.com, so make sure that all work is original, and that proper credit is given to information/ideas/authors that are referenced or cited.

Late Work

Assignments are considered late after the stated date and time, and will be penalized 10% (one letter grade) for each day they are late (including weekends). The inability to meet any deadline requires advance notification to the instructor at least 24-hours prior to the due date and time. The acceptance of late work is subject to university rules and instructor discretion, and documentation of the reason for late submission must be submitted prior to or with the late assignment for it to be considered for grading.

Students without a university-recognized excused absence will NOT be allowed to submit late work, and will receive a grade of zero. The following are the only circumstances for which makeup exams will be considered: (1) required participation in a university-sponsored activity; (2) a serious illness, injury, or unavoidable emergency; (3) required participation in active military service or jury duty; or (4) observance of an official religious holy day.

Advance notice and documentation of (1) and (4) must be submitted within the first two weeks of the semester, (3) two weeks prior to the deadline, and (2) within 24 hours of the deadline. If the above requirements are not met, a grade of zero will be entered for the missed assignment.

Course Policies

Laptop computers are allowed (and advised) in class for the purpose of taking class notes and working on in-class activities. Unrelated internet use is not allowed during class. Smartphones are permitted, provided that they are switched to silent mode and remain in your backpack, unless required by a special class activity. No calls, texting, internet use, gaming, etc. during class. If you violate this policy, you may be asked to leave class for the day.
