## IMPORTANT INFORMATION ABOUT COMPLETING THE STEPS TO ENROLLMENT

Although the steps are presented in numerical order, keep in mind that you may not necessarily complete all of these steps in the order that they are presented.

Refer to your MySJSU student account for specific deadlines and tasks that need to be completed to ensure your enrollment.

## STAY COMMITTED TO THE PROCESS

It is very important that you make note of the steps in the process and their related deadlines. We have put these deadlines in place to help you be successful on your road to enrollment. Each step in the process builds on the next and there are consequences if you miss a requirement. This means that you risk having your admission withdrawn if you do not meet our deadlines and maintain your eligibility. To prevent this from happening, sign in to your MySJSU student account ([one.sjsu.edu](http://one.sjsu.edu)) every few days and thoroughly read any messages, "To Do List" items, or posted deadlines and take the requested action as soon as possible.

# Congratulations on Your Admission!

We are excited to welcome you to San José State University, the founding campus of the California State University (CSU) system. Please know you still have steps to take to stay admitted and officially enroll for Fall 2022. This guide includes detailed information to help you complete each of the required steps.

- Pay your Housing Payment by **Wednesday, July 6** if you are planning to live on campus
- Submit final official transcripts, test scores and documents by **Friday, July 15**
- Purchase health insurance through SJSU prior to registering for classes
- Complete Immigration Document Process
- Attend your mandatory Sparta Camp (Frosh Orientation) session
- Pay Your Tuition and Fees by **Friday, August 12**
- Attend Virtual Global Spartan Welcome (GSW)
- Complete online training programs on sexual violence and alcohol abuse prevention

## Frequently Asked Questions

### What if I do not complete required courses or miss a deadline?

You will have your admission to SJSU revoked and your registration canceled. In particular, failure to submit your transcripts will result in your application being withdrawn, even if you have signed up for housing and attended orientation.

### What if I am taking courses required for admission during the Summer 2022 term?

You may not use coursework from the Summer 2022 term to complete admission requirements

### Can I defer admission to another term?

No, your admission offer is good for the Fall 2022 term only. You must attend at least one course during the Fall 2022 semester to maintain your admission. If you do not enroll in courses during the term of your admission and wish to be admitted for a later term, you must submit a new application for the next available term for which you meet the minimum requirements.

### Can I change my major?

Due to space limits in many SJSU departments, you may not change your major before the term starts. Note that change of major is never guaranteed, even after admission to SJSU.

San José State needs to know if you plan to enroll so that we can plan for your enrollment in Fall 2022. To submit your intent to enroll, go to the Next Steps Intent to Enroll website ([nextsteps.sjsu.edu](https://nextsteps.sjsu.edu)) and complete the multi-step process by 11:59 p.m. (Pacific Standard Time) on **Sunday, May 1**. Note that if you do not meet this deadline we will assume that you do not want to attend SJSU and your admission will be withdrawn.

The Next Steps Intent to Enroll process includes accepting SJSU's offer of admission, signing up for mandatory orientation, and paying the \$250 nonrefundable enrollment deposit.

**YES** – I intend to enroll at SJSU for the Fall 2022 semester.

**(Please note: You may not defer your enrollment to a later semester.)**

**NO** – I will not attend SJSU for the Fall 2022 semester.

(Your application will be withdrawn from further consideration.)

- Your SJSUOne password

Sparta Camp is a mandatory two-day in-person orientation program that will introduce you to the campus and its resources, connect you to your college and major department, and provide you with critical academic planning information. All admitted students are required to attend this mandatory orientation for the entire duration of the program. The cost to attend orientation is \$180 and will be included in your \$250 enrollment deposit.

Before attending Sparta Camp (Frosh Orientation), complete Spartan Link ([spartanlink.sjsu.edu](https://spartanlink.sjsu.edu)) Online Pre-Orientation.

#### During orientation, you will:

- Discuss and explain key university services
- Facilitate connections with other staff, faculty and your fellow incoming students
- Attend a General Education advising workshop to help in planning your academic schedule

If you do not attend, or leave during any portion of the program, you will be blocked from registering for classes and will not be able to attend SJSU in Fall 2022. Students who arrive late will not be allowed to attend the program.

In order to complete the Next Steps Intent to Enroll process and reserve your spot to attend SJSU, you must submit your nonrefundable enrollment deposit by the deadline. You will be prompted to pay your nonrefundable enrollment deposit online via a link provided in your Next Steps portal. The \$250 Enrollment Deposit includes your \$180 orientation payment and a deposit of \$70 towards your tuition and fees for Fall 2022. .

Please note: The \$250 Enrollment Deposit is nonrefundable, even if you do not enroll in classes for the Fall 2022 semester.

### International House

A large, comfortable home located near campus, the International House (I-House) is a residence for 70 U.S. and international students attending San José State. At I-House, residents find friends, study partners, and mentors in addition to opportunities for leadership, group activities and travel. I-House students represent approximately 25 countries, range in age from 17 to 35 years of age, study in a wide variety of programs offered on the SJSU campus, and enroll in graduate, undergraduate, semester and year exchange, and English language programs.

I-House stays open year-round with per diem rates during summer and winter breaks. One semester contracts are offered. To facilitate appropriate first-year course placement, the CSU evaluates your academic preparation in two areas: written communication and math/quantitative reasoning.

The evaluation takes into account several factors, including overall grade point average, mathematics grade point average, completed terms of secondary coursework, grades in certain senior year classes, reflection on college writing, and scores on standardized tests such as the SAT, ACT, CAASPP/EAP, CLEP, Advanced Placement, Advanced Level, Advanced Subsidiary, and International Baccalaureate examinations.

Though SJSU will not consider SAT/ACT scores in our evaluation of your record for admission, please submit any available official SAT/ACT scores as they could help determine your first-year course placement.

### First Year Writing Course Placement

Freshmen entering SJSU will complete an online Reflection on College Writing exercise to explore writing at SJSU and to choose the course they need. The online exercise is offered through Canvas (SJSU's online course tool). Be alert for emails and MySJSU messages about the Reflection on College Writing. To ensure that you will be able to register for your first-year writing course during the Frosh Orientation (Sparta Camp), complete all modules in your Reflection on College Writing at least two weeks prior to your orientation session. Messages and emails will be posted if there are sections that are not fully complete - be sure to monitor MySJSU and your @sjsu.edu email account.

### First Year Math Course Placement

Your math placement is dependent upon your major and your enrollment category. You can confirm your major by reviewing your admission letter. To determine your math course placement and whether you may need to participate in preliminary coursework this summer, please complete both of the following:

- Determine if your major requires Calculus by viewing the Majors Requiring Calculus (STEM) list at [sjsu.edu/supportedinstruction/first-year-course-placement/math-quantitative-reasoning](http://sjsu.edu/supportedinstruction/first-year-course-placement/math-quantitative-reasoning)
  - If your major requires Calculus, please review the Precalculus Proficiency Assessment section below
- AND-
- Identify your math enrollment category by following the instructions at [sjsu.edu/supportedinstruction/first-year-course-placement/math-quantitative-reasoning](http://sjsu.edu/supportedinstruction/first-year-course-placement/math-quantitative-reasoning)

### Precalculus Proficiency Assessment

If your major requires calculus you will be required to take the Precalculus Proficiency Assessment (PPA) to register for Calculus unless:

- **You have earned a three or better on the AP Calculus Exam.**  
(Request to have the testing agency send your official score report sent to SJSU as soon as it is available)
- OR-
- **You have earned a C- or better in a transferable Pre-Calculus level course at a community college.**  
(Send us your official transcript reflecting this work as soon as possible.)

Students requesting testing accommodations due to disability limitation(s) must register with the Accessible Education Center at least one month prior to testing. Register online at [tinyurl.com/AECreg](http://tinyurl.com/AECreg)

If you took the Calculus AP exam in high school, and have not yet sent us your scores, please contact the Testing Office at [testing-office@sjsu.edu](mailto:testing-office@sjsu.edu) to determine your next steps.

If you feel that your assigned mathematics enrollment category is not accurate, you may submit an appeal. For your appeal to have merit, it must bring to light new or missing information that was not considered in the original determination. Transfer coursework submitted after the transcript deadline or test scores sent after the official test score deadline are the basis for an appeal. # Submit Proof of Vaccination and Immunizations

## COVID-19 Vaccination Requirement

The deadline for incoming Fall 2022 students to complete their COVID-19 two-step self-certification requirement is June 1, 2022.

Per California State University (CSU) policy, students, faculty and staff must be fully vaccinated, including a booster shot, against COVID-19 if they are accessing campus facilities at any university location across the 23 campuses. The CSU's COVID-19 vaccination policy will allow medical and religious exemptions.

## Submit Proof of Vaccination

You must complete both of the following steps to meet the June 1, 2022 deadline for compliance.

### Step 1: Complete the COVID-19 Vaccine Self-Certification form in MySJSU.

You will be asked to certify your current vaccination status or indicate if you qualify for a religious or medical exemption. Students requesting a religious exemption can upload their supporting documentation as an attachment on the COVID-19 Vaccine Self-Certification form. Prior to submitting a religious exemption form, please convert the PDF into a .BMP, .JPG, .JPEG, .GIF, and .PNG, type attachment. All other attachment types will not be accepted.

### Step 2: Submit proof of COVID-19 vaccination in the Student Health Center Patient Portal.

You will need to submit proof of your COVID-19 vaccination record and/or request for a medical exemption. Proof can include a scanned/photocopy of your vaccine card or a record containing all of the following: full name, date of birth, manufacturer/brand of vaccine, vaccine lot number, administration date and site. Please ensure all information is visible and legible in English to prevent delays in verification.

The status will read "awaiting review" in the Medical Clearances section once submitted.

## Additional Required Immunizations

In addition, as a new student, you will also need to provide proof of the following immunizations prior to the first day of classes:

- Measles, Mumps and Rubella Vaccine
- Varicella (Chicken Pox Vaccine)
- Tetanus/Pertussis/Diphtheria Booster (Tdap)
- Meningococcal conjugate
- Hepatitis B Vaccine

### F-1 Visas

#### Coming from a U.S. Institution

To complete this process, you must do the following: Show your admission letter and the SJSU “SEVIS Transfer In Form” to your current school’s international office.

This form is not mandatory but optional; it is used to let your current institution know that you wish to transfer to SJSU. Once your current institution sends your electronic I-20 document through SEVIS, then you will receive a Transfer-Pending Form I-20 from SJSU.

#### Coming from Outside the U.S.

You will receive a U.S. Immigration Form I-20 directly from San José State in the mail with your letter of admission. To start the process to obtain an F-1 student visa, first complete the I-901 form online through SEVIS at [ice.gov/sevis/i901](https://ice.gov/sevis/i901) then pay the SEVIS fee and print out the receipt. To obtain your F-1 visa, make an appointment for a visa interview and go to the nearest U.S. Consulate with the following:

- Your current passport
- SJSU admission letter
- Your I-20 (Certificate of Eligibility) form
- Proof (receipt) of SEVIS payment
- Proof of financial support

Other supporting documents, as indicated on the website of the U.S. Embassy or Consulate you will be visiting

#### Customs and Immigration at the Airport

Please expect this process to be a lengthy experience and prepare in advance. You must keep the following documents in your carry-on luggage so you are able to present them to a Customs and Border Patrol officer:

- Passport (must be valid for at least six months after the date of entry)
- F-1 visa stamp, valid at the time of entry\*
- Form I-20, must be valid
- Proof of financial support and resources reflected on Form I-20
- Tuition and/or Housing receipt(s), if you have made payments prior to your arrival
- SEVIS fee receipt

Canadian citizens are not required to apply for a visa to enter the U.S. as an F-1, but must still pay the SEVIS Fee and present their Form I-20 at the U.S. port of entry.

### Fees are Subject to Change

The CSU makes every effort to keep student costs to a minimum. Fees listed in published schedules or student accounts may need to be increased when public funding is inadequate. Therefore, CSU must reserve the right, even after initial fee payments are made, to increase or modify any listed fees, without notice, until the date when instruction for a particular semester or quarter has begun. All CSU listed fees should be regarded as estimates that are subject to change upon approval by The Board of Trustees, the Chancellor, or the Presidents, as appropriate. Changes in mandatory systemwide fees will be made in accordance with the requirements of the Working Families Student Fee Transparency and Accountability Act (Sections 66028 - 66028.6 of the Education Code).

### Third Party Sponsors

If a Third Party Sponsor, such as a foreign government agency, a business and/or educational institution, agrees to sponsor you by paying your tuition and fees, please get an authorization letter from the sponsor stating how much of your tuition they will cover and for which semesters. Submit the authorization to SJSU's Bursar's Office, Attention: Third Party Technician and retain a copy of the letter for your records.

The Bursar's Office will invoice the sponsor as appropriate for tuition and fees after the add/drop period as long as the sponsored student is registered and has submitted a current letter of authorization.

## Installment Payment Plans

The university offers payment plans to assist students and their families in making their payments over a period of time. Two payment plans are offered for the fall and spring semesters:

- Tuition and fees payment plan
- Housing payment plan

Students may sign up for both plans if needed and each payment plan has a \$35 fee. The initial payment includes campus mandatory fees, optional SIRF fee, First Day Solutions charges and miscellaneous class fees. These fees must be paid by your payment due date and are not included in the installments.

Eligible charges that can be divided into the installment payments include tuition fees, non-California resident fees, and graduate professional business program fees. A student must have a minimum of \$1,000 in eligible charges to qualify for the payment plan. Visit <https://sjsu.edu/bursar/payment-refunds/installment-payment-plan.php> for more information.

## International Wire Transfers

International students can now make payments via international wire transfer. San José State University has partnered with Flywire to streamline the tuition payment process for our international students. Flywire offers excellent foreign exchange rates, allowing you to pay in your home currency (in most cases) and save a significant amount of money, compared to traditional banks. You will be able to track the progress of your payment throughout the transfer process via a student dashboard, and you will also be notified via email when your payment is received by San José State.

There is no fee charged by SJSU or Flywire for international wire transfers. The bank you use to send the wire transfer usually charges a fee, so check with that bank for the fee schedule.

## Bookstore Charges

## Keeping Your MySJSU Account Current

SJSU has established a business practice whereby all payments apply to the oldest debt on your account. For example, if you are making a registration payment and you have a housing debt with an earlier due date, the payment will apply to the housing charges first. Keep your account current to avoid the possibility of enrollment cancellation.

Any delinquent outstanding charges owed to the university will be submitted to the Franchise Tax Board for tax refund offset. The university, or its agent, has the right to pursue collections in order to repay a delinquent debt owed to the university.
