# Introduction

We began the year with an 'Away Day' at Studio-on-the-Street in San José. During this half-day retreat in September 2024, we discussed how to deliver our degree programs more effectively, and shared strategies for teaching excellence and engagement with students. One of the ideas to emerge from the retreat was an undergraduate research symposium.

In May 2025, we held our first Student Research Symposium for undergraduates in conjunction with our annual Graduate Showcase event. A panel of judges—Jodie Warren, Justin Strong and Dallas Augustine—reviewed the posters, and Dr Strong presented awards for the top research projects at the Celebration of Achievement event later that morning. This year, we also held a student paper contest with prizes for winning entries. Gabriela Gonzalez chaired the faculty committee reviewing the papers.

Looking ahead, Nurettin Senol will join us as assistant professor in Fall 2025. He has completed a PhD in Digital and Cyber Forensics at Sam Houston State University and will bring his expertise to the digital evidence concentration in forensic science.

The Department continues to work with the College of Social Sciences to develop new space on campus: a larger teaching laboratory for forensic science and a research laboratory for forensic entomology and taphonomy in the Science building, and a mock courtroom for criminology and legal studies in the Boccardo Business Complex.



Peggy Stevenson and the RCP team received three grants from Destination:Home, a program dedicated to preventing and ending homelessness:

- \$50,200, of which \$42,000 is for direct client support for employment-related needs such
- as work clothes, equipment, and a range of things to enable people to gain and retain
- employment.
- \$40,000 to provide legal services to people who are experiencing housing insecurity.
- \$18,000 to provide clients with technology such as laptops or cell phones. This funding
- has been used to support RCP's digital literacy courses.

In Fall 2024, long-time RCP donors established an endowment for RCP to ensure its legacy in providing exceptional educational experience to SJSU students and life-changing services to community members. Annual support from the endowment will begin in three years, in increasingly greater amounts.

Jodie Warren and Mary Juno received a General Education Summer Grant of \$2000 from SJSU's Office of Undergraduate Education to develop a new course FS 172 Ethics and Error in Forensic Science, June 2024.

# Record clearance project

The Record Clearance Project (RCP), founded by Peggy Stevenson, provides students pursuing a career in legal services with an experience advocating for clients eligible for expungement of criminal records under California law. RCP makes SJSU the only university in the USA to offer a clinical legal program to undergraduates.

*Service navigation*. RCP's service navigation peer mentor program assists people being released from custody with peer mentorship combined with case management and service navigation. RCP's peer mentors, who have been formerly incarcerated themselves, provided peer support to 232 people who were released from custody, assisting them in linking them to needed services 6,283 times over the past year.

*Legal Services*. RCP provided 38 legal rights presentations at 23 different facilities and organizations; 1,048 people attended, including 655 people currently in custody. Students and a former client do these presentations in English and Spanish, with an attorney attending.

RCP provided free brief legal service interviews to 390 clients in the past year. At these interviews, clients received advice on clearing their criminal records. When Santa Clara County cases could be dismissed without court hearings, RCP completed the necessary forms to do so. To complete this brief legal service work, RCP:

- Provided expungement advice on 2,212 cases.
- Completed 240 record clearance application forms seeking dismissal of 1,183 convictions.
- From these 390 interviews, 190 clients were able to have their records completely cleared.
- Obtained 601 free criminal history reports (RAP sheets).

*Court representation.* For clients whose cases were more serious, RCP represented 19 clients at court hearings, with a total of 53 cases on the docket. All convictions were dismissed.

Digital Literacy Classes. In the past year, with funding provided by Santa Clara County upon Supervisor Susan Ellenberg's recommendation, RCP provided free digital literacy courses to formerly incarcerated people. The program provides laptops for participants to learn the basics of computer operation and programs. To date this year, 68 participants have completed the program, earning the laptops they were trained on in recognition of their involvement. RCP student interns assist RCP staff in the classes.

ASB Week. Between March 24 and March 28, 2025, Stanford and Berkeley law students spent their spring breaks working with RCP students to prepare court petitions for record clearance. RCP trained the law students on record clearance law, trauma-informed interviewing, and partnered with RCP advanced students (JS 141) to interview clients and collect information for their court petitions.

The law students provided over 450 hours of volunteer legal services work to assist nine RCP clients in putting together record clearance petitions. By May, six clients have had their records cleared.





Ivan Santana (BS 2018) has been appointed detective in the Detective-Investigations Bureau with the City of Marina Police Department.


