## 1. Biosafety Officer's news

No incidents to report.

#### 2. IBC news

To assist in providing a quorum, the Chair invited Ningkun Wang to participate as a voting alternate member for Cleber Ouverney. The committee agreed and proceeded to conduct business.

Members were informed that research "Development of antibacterial treatment strategies" was flagged by NIH as potentially violating the Dangerous Gain of Function (GOF) Research executive order (Notice Number: NOT-OD-25-127, May 2025). Principal investigator (PI), Laura Miller Conrad, provided an overview on the information required by NIH with a five-day turnaround. Members were also informed that a DURC questionnaire is being developed to assist PIs to identify DURC activities, and it will be sent to the members for review. Members were reminded to take the CITI Dual Use Research of Concern (DURC) training which covers specific guidelines related to this type of research, including the agents and types of experiments requiring IBC oversight. Dr. Laura Miller Conrad left the meeting at 1:30 PM.

The Chair presented the revised Annual Continuing Review Report Form to accommodate both research and teaching BUAs. The revised form was **unanimously approved** by the Committee.

A procedure to follow when the PI of an active research BUA goes on sabbatical was discussed. The Chair proposed that the PI taking a sabbatical (or medical, or family-related leave) should notify the IBC, designate a qualified individual replacement, update the BUA, review all protocols, and confirm the staff training. This process will help maintain compliance with biosafety regulations and ensure continuity of oversight during the PI's absence. Members wondered whether a technician may serve as interim PI. Also, another consideration is that not all leaves are equal; some allow faculty to remain research-active while others may prohibit it. The College of Science has the most experience with this issue and will provide guidance to the university leadership.

Maria Piccone, Chair of the IBC, announced she will leave the University in December 2025. The Vice-Chair thanked her for her dedicated service and the committee applauded her efforts on behalf of SJSU.
